## +14 points since 2021 : significant progress

Between 2021 and 2025, FREY has significantly strengthened its actions across all areas assessed by B Lab. This increase of over 14 points demonstrates a heightened level of ambition, continuous improvement, and deeper integration of ESG (Environmental, Social, Governance) concerns across the Group's operations.

With this new score, FREY has progressed across each of the five fundamental pillars:

- Workers (+4.6 points): Financial security, health, well-being, professional development, and engagement
- Environment (+5.6 points): Carbon footprint, resource management, biodiversity
- Community (+3.0 points): Local impact, diversity, equity, inclusion, and supplier relationships
- **Customers** (+0.4 points): Service quality, ethical marketing, data protection
- Governance (+0.2 points): Transparency, ethics, social and environmental mission

With this new score, FREY demonstrates that an alternative business model is possible and also high performing.

This recognition strengthens the Group's belief that reconciling economic profitability with the common good is essential to building the future of our communities.
